## 17/17 Applications to be Considered

The Committee considered a report from the Director of Strategic Partnerships, Planning and Streetpride on planning applications which were to be determined by the Committee.

12/15/01570 – Site of Rose and Crown PH and St. Ralph Sherwin Centre, Swarkestone Road, Chellaston

(Demolition of existing buildings and structures and erection of retail store (use class A1), carparking and servicing areas, access and associated works)

The Development Control Group Manager reported that the following late items had been received and circulated to the Committee:

- a number of letters of objection, including comments from Chellaston Residents Association, comments from Chellaston Neighbourhood Planning Forum and one letter relating to biodiversity and hedgerow issues; and
- a petition in objection (sample circulated).

Joanne Hawley, Lidl, addressed the Committee. Mr Bowden, Chair of Chellaston Residents Association, Mrs Withford and Councillor Ingall, as Ward Councillor, addressed the Committee and made representations against the application.

**Resolved:**

- 1. to reject the officer recommendation and refuse planning permission; and**
- 2. to nominate Councillor Care to represent the Committee at any future appeal.**

**Reason for Refusal**

- 1. In the opinion of the Local Planning Authority the proposed development would create, by virtue of the excessive footprint of the building, the sub-standard architectural design of the building and the poor overall layout of the car park, an unacceptable form of development in design terms that would be distinctly out of character with the Chellaston District centre. As such, the proposal is contrary to policies CP3 and CP4 of the adopted Derby City Local Plan Part 1: (Core Strategy), saved policy GD5 of the adopted City of Derby Local Plan Review and the guidance in paragraph 56 of the National Planning Policy Framework which attaches great importance to the design of the built environment.**
- 2. In the opinion of the Local Planning Authority the proposed development would create, by virtue of the proposed single point of access to the site and the relationship of that access to the neighbouring Chellaston Academy, an unacceptable form of development in terms of vehicle and pedestrian safety on the public highway, particularly at peak times when pupils and others are travelling to and from Chellaston Academy. As such, the proposal is contrary to policy CP23 of the adopted Derby City Local Plan Part 1: (Core Strategy) and the guidance in paragraph 32 of the National Planning Policy Framework which requires development proposals to provide safe and suitable access to sites for all people.**

01/17/00030 – Site of former Derbyshire Royal Infirmary, London Road, Derby

(The construction of upto 500 dwellings (Class C3 and Class C2) and for 1,000 sqm (max) Class A1 (shops); 500sqm (max) Class A3 (restaurants & cafes); and 1,100 sqm (max) Class B1(a) (offices)/A2 (financial & professional services); and for Class D1/D2 (non-residential institutions/assembly and leisure), Class A4 (drinking establishments) together with access, public open space, landscaping and associated engineering works and the demolition of a former hospital building)

The Development Control Team Leader addressed the Committee and introduced the item.

Members raised concerns regarding the proposal as part of the application to demolish one of the “two pepperpot towers” and proposed to defer consideration of the application for further discussions to take place with the developer to consider its retention.

**Resolved to defer the matter to a future meeting.**
