On 19 June 2016 unauthorised works were carried out to 2 Lime Trees protected by TPO 2014 Number 583 located at the former Cavendish Public House Walbrook Road Derby.

It has been a protracted investigation due to extended enquiries to identify those responsible and have them attend a formal interview.

All the relevant information and evidence is now being collated and will be submitted for formal consultation to our Legal Division as soon as possible.

The matter has now been considered by our Legal Division and prosecution proceedings have been authorised against those responsible. The matter has been scheduled for a first hearing on 2 February 2017 at Southern Derbyshire Magistrates Court.

On the 2 February at Southern Derbyshire Magistrates Court the defendant pleaded not guilty to the charges laid against him, the matter was adjourned until 2.15 pm on Thursday 11 May 2017at Southern Derbyshire Magistrates Court.

On 11 May 2017 at Southern Derbyshire Magistrates Court the defendant appeared for trial. The defendant was found guilty under Section 210(4) Town and Country Planning Act 1990 on both charges of Causing or Permitting the carrying out of unauthorised works to 2 protected lime trees.

The Magistrates imposed the maximum fine allowed for each offence £2,500 (£5,000) together with costs of £1,900 a total of £6,900 and a criminal conviction.

In their summing up the Magistrates concluded that the defendant's evidence was inconsistent, lacked credibility and there was a significant difference between his versions of the events given during his tape recorded formal interview and the evidence he gave on the day of his trial.
