**Application for an expedited/summary review of a premises
licence at: D’Gios 17 Victoria Street Derby DE1 1ES**

Purpose

- 1.1 An application for an expedited/summary review of the Premises Licence at D’Gios, 17 Victoria Street, Derby DE1 1ES from Derbyshire Constabulary by Derby City Council’s Licensing Team on 21 May 2019 at 13:10 hrs.
- 1.2 This type of application allows the police to fast track a review of the premises licence where they consider the premises are associated with serious crime or disorder or both.
- 1.3 This allows the Licensing Authority to respond quickly where appropriate by taking interim steps.
- 1.4 The application must be on a prescribed form and be accompanied by a certificate issued by a senior police officer
- 1.5 The General Licensing Sub Committee can decide to:
 - modify the conditions of the licence;
 - exclude a licensable activity from the scope of the licence;
 - remove the Designated Premises Supervisor;
 - suspend the licence
- 1.6 Following an expedited/summary review a full review of the Premises Licence must take place within 28 days

- 4.3 The required notice advertising the review and inviting representations was published and displayed on 22 May 2019 at the premises.
- 4.4 **The current licensable activities are:**
- The sale by retail of alcohol (off/on the premises)
 - Regulated Entertainment ; films, live music, the playing of recorded music, performance of dance and anything similar
 - The provision of late night refreshment
- 4.5 A copy of the current premises licence and a location plan of the premises are attached at appendices 2 and 3 respectively.
