Listed Building:

Object to introduction of balconies to thefirst floor and 'false roof', both of which would be harmful to the character and appearance of the conservation area. Balconies are not a historic feature. They were previous accepted at the higher level where they have a less intrusive impact, but not at first floor. The false roof is also unacceptable and a retrograde step and should be amended back to a true dual pitch roof. The proposed materials, i.e. concrete roof tiles, upvc windows/doors and fascia, and reconstituted stone window heads are also inappropriate within the conservation area and harmful to its character and appearance.

Committee also noted that works have been carried out on site that do not correspond with either the approved scheme or the revised proposals, and which are unacceptable due to the size of the first floor openings and the use of upvc for window frames. Recommended Enforcement Action.

Object. Noted some of the buildings on the site date from 1851 and that this was historically an area of small scale industries adjacent to the canal and river. The 'mill' scale is not appropriate to this location, Spring Cottage should be retained and incorporated into any future proposal for the site, which should be in scale with the surroundings. It was noted that the taller building on Mansfield Road pre-dated the DVMWHS designation. The scale and massing of the proposed scheme would be harmful to the setting of the Grade I Bridge and Bridge Chapel, and the locally listed Bridge Inn. The Historic England comments on this application are supported. The amendments have not addressed the issues previously raisedby committee, and therefore the previous resolution stands, adding the objection to the setting of the listed building.
