Joined Up Care Derbyshire Update - Frailty Model

Purpose

1.1 This report outlines the Derbyshire Community Frailty Model including an overview of the Joined Up Care Derbyshire Frailty Summit held last year and subsequent work to progress the model.

Recommendations

- 2.1 To note the progress made on frailty in Derbyshire.
- 2.2 To support the Derbyshire Frailty Model and a collaborative approach to deliver better outcomes for the local population.

Reasons

- 3.1 Frailty has a significant impact on the health and wellbeing of many local people and also on the demand for health and social care services.
- 3.2 This work supports the Health and Wellbeing Board in its responsibility to improve the health and wellbeing of local people.

Supporting information

- 4.1 Frailty is an increasingly significant issue in Derby and Derbyshire impacting on the health and wellbeing of people of all ages but most commonly older people.
- 4.2 In addition to the impact on individual health and wellbeing, frailty has an impact on the demand for health and social care.
- 4.3 For these reasons, developing an approach to frailty has been agreed as a priority within Joined Up Care Derbyshire.
- 4.4 Work has been undertaken to build relationships to further improve the quality of care for older people including those with frailty and multi-morbidity to develop a community frailty model.

- 4.5 A Frailty Summit was held in last year to bring together stakeholders from across the system to:
 - Further develop the model;
 - Support the case for a collaborative approach to deliver better outcomes for the population;
 - Introduce the Derbyshire Community Frailty Model as an enabler of collaboration.
 - Identify next steps in delivering the Frailty Model's Vision.
- 4.6 Since the Summit, work has been ongoing to deliver the Frailty Model Vision.
