17. **Notice of Motion: Delivery of Brexit**

Moved by Councillor A J Graves, seconded by Councillor A W Graves

On June 23rd 2016, 52 per cent of the people of the United Kingdom voted to Leave the European Union and the people of Derby voted 57 per cent in favour of leaving.

Since then the government, under Theresa May's leadership, has consistently said that she will carry out the wishes of the people and has abjectly failed that task.

The uncertainty of decision making has made our country, and city, uneasy about the future.

Derby City Council calls on, and will write to, the new Prime Minister to deliver a true Brexit, without further delay on, or before, the end of October 2019.

18. **Notice of Motion: Impact of Universal Credit**

Moved by Councillor Russell, seconded by Councillor Eldret

Full roll out of Universal Credit began in Derby just over one year ago. The detrimental effects of this change to social security has been felt by many residents in Derby.

This Council notes the five-week wait for Universal Credit claimants to access any support has pushed many families into poverty and led to many of them being unable to pay bills and fall behind with rent payments.

This council supports the assessment made by Philip Alston, the UN rapporteur on extreme poverty and human rights, that the Government's policy changes in social security has led to the "systematic immiseration of a significant part of the British population".

Council calls on the Government to immediately stop and scrap the unfair system of Universal Credit.

The Council further calls on the Council Cabinet to transfer funds as a matter of urgency to the Welfare Reform Reserve to support Derby's residents with the ongoing impact on Universal Credit.

19. Notice of Motion: Electoral reform

Moved by Councillor Kus, seconded by Councillor Bettany

Council recognises that the 'First Past the Post' system of voting that has been used in Britain since 1888 is no longer fit for purpose.

First Past the Post results in tactical voting and gerrymandering, causing many people to feel that their vote has been wasted.

Council resolves:

- *To request the Cabinet Member for Governance and Licensing write to the Government, lobbying for electoral reform and stating that First Past the Post is no longer fit for purpose.*
- *To work with the Electoral Reform Society in order to achieve a fairer voting system for Derby.*

20. Notice of Motion: Reducing plastic and other single-use waste

Moved by Councillor Care, seconded by Councillor Naitta

Recent research and publicity have highlighted worldwide impacts of plastic waste. This indicates that leadership and action are needed to reduce plastic waste, including micro-particles, entering our wider environment.

This Council therefore agrees to stop using single-use plastics as far as possible, including beakers and cutlery, and to avoid using products with microbeads and similar microplastic particles. Council further seeks to minimise use of other single use materials, including glass bottles, and will

seek to reduce excessive use of, especially plastic, packaging. This is to include procurement to cover sub-contracted services.
