CAAC objected to the design which they felt did not reflect the significance of the site, particularly in terms of appearance/ elevational treatment and materials. CAAC also felt the building would be detrimental to the setting of heritage assets in vicinity particularly the Bonded Warehouse. Archaeological conditions should be included for on site works. The siting of development was in isolation of the rest of the heritage asset, which CAAC felt regrettable. The status of the boundary wall needed clarifying.

CAAC felt it was disappointing that the proposal was of a standard format and didn't take account of historic context. The view from Stafford Street would be poor and tree screening should be considered.

CAAC welcome the reduction in both the height and scale of the building which they felt was an improvement on previous proposal but still objected on grounds of the negative impact on setting and significance of Pickfords House and character of the Conservation Area by reason of height and scale. The Committee still requested further reduction in height particularly to the rear section nearest to Pickfords House. They felt staggering the height of building was appropriate on Agard Street but not facing Pickfords House, which would impinge on the setting of the building. It was felt that stepping down to five storeys would set a marker for adjacent developments beyond Friar Gate Bridge.

CAAC felt the architectural design quality was not sufficient for this setting/ context as well as excessive scale and inappropriate materials which they felt would have a negative impact on the character/ significance of the Conservation Area. CAAC also objected to the unnecessary loss of trees which they felt would make the proposed out building more prominent. The Committee stated they would prefer an innovative design which would respect the area's character. Concerns were raised on the

archaeological impact which would be likely on Roman fort and it should be controlled by condition.

CAAC felt the design and proposed external material changes undermined the quality of the development. The Committee felt there was no justification or supporting statement for the changes submitted with the application. They felt the overall set of changes were a retrograde step to the quality of scheme. CAAC felt UPvc windows were not acceptable in a Conservation Area. The Committee felt this design had a negative impact on significance and character of the Conservation Area and setting of listed buildings, particularly in relation to change in materials, additional roof lights, loss of chimneys and addition of dormers. Greater clarity of proportions of windows and dormers was requested.
