Friar Gate Bridge – Draft Options Viability Study and Option Appraisal Cost Report

SUMMARY

- 1.1 The Friends of Friar Gate Bridge charity, supported by the Heritage Lottery Fund has commissioned Latham's to undertake an Options Viability Study to support an application to the HLF (Round 1) and an Options Appraisal of Costs. Derby City Council is also supporting the charity and have inputted into the brief for this work and attended meetings of the steering group and public meetings.
