

## General Licensing Fees and Charges 2018/19

### SUMMARY

- 1.1 The Communities & Place Directorate annually reviews its fees and charges across its range of services. This is to ensure that the fees and charges reflect the cost of delivering services and that inflationary cost increases are taken into account.
- 1.2 The proposed fees and charges for 2018/19 commencing 1 April 2018 are set out in Appendices 2 and 3. The amounts charged are either set by statute or are based on recovering the costs incurred. Appendix 4 outlines the fees that are set wholly by statute.
- 1.3 All charges are outside the scope of VAT.

### RECOMMENDATION

- 2.1 Approve the proposed fees and charges for 2018/19 set out in Appendices 2 and 3.
- 2.2 Note the fees and charges made under the Licensing Act 2003 set out in Appendix 4.

### REASONS FOR RECOMMENDATION

- 3.1 To ensure that the fees and charges for services provided during the next administrative year comply with and can be justified on the basis of statutory cost recovery principles, where applicable.

### SUPPORTING INFORMATION

- 4.1 As part of the 2018/19 budget preparation, Departments within the Communities and Place Directorate have reviewed their fees and charges. This annual review is necessary to ensure that:
  - Any additional costs (or efficiencies) of providing the service are incorporated
  - Fees and charges reflect the cost of delivering the service

- 4.2 The proposed general licensing fees and charges for 2018/19 are set out at Appendices 2 and 3. All fees listed in Appendix 2 are based on cost recovery and inflationary cost increases.
- 4.3 Appendix 3 lists the fees chargeable under the Gambling Act 2005. Licence fees where permitted, are based on cost recovery up to the maximum permitted level. Permit and administrative fees, such as copy licence fees are set by statute.
- 4.4 Appendix 4 lists all fees chargeable under the Licensing Act 2003. All these fees and charges are set in statute.
