DER/07/16/00837	The Audley Centre, 21-33 St. Peters Street & 22-38 East Street, Derby	Full Application – Erection of additional storeys at 21-23 St Peter's Street and 22-36 East Street to provide 48 residential units (use class C3), alterations to the first and second floor elevations and change of use of 21 St Peter's Street from retail (use class A1) to restaurant (use class A3).
DER/10/16/01223	Victory Park, Victory Road, Derby	Full Application – Erection of a joinery workshop (use class B2) with ancillary offices and staff facilities.
DER/10/16/01228	25-33 Babington Lane, Derby	Full Application – Conversion and change of use of first and second floor to studio flats and the construction of additional floors over to create 81 studio apartments.
DER/10/16/01253	Plot C, Derby Commercial Park, Raynesway.	Full Application – Erection of 2 warehouse units with flexible B1 B/C, B2 or B8 use together with associated ancillary office accommodation, means of access, parking, service, ancillary structures and landscaping.
DER/10/16/01292	Vacant Land, Parcel Terrace, Derby (Former site of TDG Novacold)	Full Application – Change of use of vacant land for the storage and distribution of site cabins and associated site materials (use class B8) including the erection of operational site cabins and welfare facilities.
