CAAC repeated the previous comments of 7 December 2017 which read...

Object and recommend refusal. The Committee felt that the proposed development was too large for its location, overbearing and imposing. It was felt that the development would not enhance the character and appearance of either the conservation area of the range of listed buildings in the area. The Committee felt that the proposal would also be injurious to the amenities of neighbours opposite by virtue of the scale and mass of the proposed built form. Proposed development would exhibit and be unduly detrimental frontage form of development on Agard Street.

Committee also felt that the resolution should be expanded to address the substantial harm of the development to the setting of adjacent listed buildings and the character and appearance of the Friar Gate Conservation Area to which it does not preserve or enhance. CAAC also expressed concerns about the mental health implications (for any future occupants) as a result of the over-intensive form of development, the size of the individual residential units and the paucity of open space provision.
