# Application for a review of a premises licence at: Premier Rowditch 211-213 Uttoxeter New Road Derby DE22 3LJ

#### **Purpose**

- 1.1 An application for an expedited/summary review of the premises licence at Premier Rowditch, 211-213 Uttoxeter New Road, Derby DE22 3LJ was received from Derbyshire Constabulary by Derby City Council's Licensing Team on 12 December 2019.
- 1.2 A hearing was held on 16 December 2019 at which interim steps were taken by the General Licensing Sub Committee.
- 1.3 Following an expedited/summary review a full review of the premises licence must take place within 28 days of the Licensing Authority receiving the expedited review application, hence the hearing today.
- 1.4 The sale by retail of alcohol must be licensed under the Licensing Act 2003.
- 1.5 The General Licensing Sub Committee can decide to:
  - modify the conditions of the licence;
  - exclude a licensable activity from the scope of the licence;
  - remove the designated premises supervisor;
  - suspend the licence for a period not exceeding three months or,
  - revoke the licence

#### Recommendations

2.1 To consider the information in the report and any relevant representations to determine the review of the premises licence at: Premier Rowditch, 211-213 Uttoxeter New Road, Derby DE22 3LJ.

#### Reason

3.1 To ensure that the four licensing objectives are upheld in relation to a review of the premises licence at: Premier Rowditch, 211-213 Uttoxeter New Road, Derby DE22 3LJ, following an expedited/summary review.

  - the sale by retail of alcohol (off the premises)

Good Friday 08:00 to 22:30hrs
Christmas Day Noon to 15:00hrs
Christmas Day 19:00 to 22:30hrs

4.7 The current days and times the premises are open to the public are:

Sunday to Monday 10:00 to 03:30hrs

- 4.8 The current premises licence holder is: Balran Services Ltd
- 4.9 The current designated premises supervisor is: Baljinder Kaur Mann
- 4.10 A location plan of the premises is attached at Appendix 3.
- 4.11 A copy of the premises licence is attached at Appendix 4.
- 4.12 The Committee is obliged to determine this application with a view to promoting the licensing objectives which are:
  - the prevention of crime and disorder;
  - public safety;
  - the prevention of public nuisance;
  - the protection of children from harm.
- 4.13 In making its decision, the Committee is also obliged to have regard to national Guidance issued under Section 182 of the Licensing Act 2003 and the Council's own Licensing Policy.
- 4.14 The Council recognises the importance of securing proper integration with and attaching relevant conditions that reflect local strategies.
- 4.15 The Council has a duty to act in a manner which is compatible with the Human Rights Act 1998.

4.16 A Licence is regarded as property for the purposes of the Human Rights Act 1998. Article 1 of the First Protocol states that:

"Every natural or legal person is entitled to the peaceful enjoyment of his possessions. No one shall be deprived of his possessions except in the public interest and subject to the conditions provided for by law and by the general principles of international law.

The preceding provisions shall not, however, in any way impair the right of a State to enforce such laws as it deems necessary to control the use of property in accordance with the general interest or to secure the payment of taxes or other contributions or penalties."

- 4.17 The Committee must also take into account the effect on local residents. Article 8 states:
  - Everyone has the right to respect for his private and family life, his home and his correspondence.
  - There shall be no interference by a public authority with the exercise of this right except such as is in accordance with the law and is necessary in a democratic society in the interests of national security, public safety or the economic well-being of the country, for the prevention of disorder or crime, for the protection of health or morals, or for the protection of the rights and freedoms of others.
- 4.18 Three stage test to be applied:
  - Is the interference in accordance with the law?
  - Is the interference necessary in a democratic society in pursuit of one of the legitimate aims set out above?

Is the decision proportionate i.e. Striking a fair balance between the demands of the general interests of the community and the requirement to protect the individual's fundamental rights?
