Application for the transfer of a premises licence at: Zielona Zabka 15 – 17 Sinfin Lane Derby DE24 9GP

SUMMARY

- 1.1 An application for the transfer of the premises licence was received by Derby City Council's Licensing Team on 12 June 2018 from Ewelina Latif.
- 1.2 On 25 June 2018 a relevant representation was received from Derbyshire Constabulary, a responsible authority.
- 1.3 The General Licensing Sub Committee can decide to:
 - Reject the application if it considers it necessary for the promotion of the crime prevention objective to do so: or
 - To grant the application.

RECOMMENDATION

2.1 To consider the information in the report, consider the application and any relevant representation to determine the transfer of the Premises Licence at: Zielona Zabka 15 – 17 Sinfin Lane Derby DE24 9GP.

REASONS FOR RECOMMENDATION

3.1 To ensure that the four licensing objectives are upheld in relation to the application for a transfer of the Premises Licence at: Zielona Zabka 15 – 17 Sinfin Lane Derby DE24 9GP.

SUPPORTING INFORMATION

- 4.1 An application for the transfer of the premises licence was received by Derby City Council's Licensing Team on 12 June 2018 from Ewelina Latif; trading as Zielona Zabka. A copy of the application is attached at Appendix 2.
- 4.2 On 25 June 2018 a relevant representation was received from Derbyshire Constabulary, a responsible authority. In this particular type of application only the police are permitted to submit a representation. A copy is attached at Appendix 3.
- 4.3 A copy of the current premises licence is attached at Appendix 4.

- 4.4 A location map is attached at Appendix 5.
- 4.5 The Committee is obliged to determine this application with a view to promoting the licensing objective that deals with the prevention of crime and disorder.
- 4.6 In making its decision, the Committee is also obliged to have regard to National Guidance issued under Section 182 of the Licensing Act 2003 and the Council's own Licensing Policy.
- 4.7 The Council recognises the importance of securing proper integration with and attaching relevant conditions that reflect local strategies.
- 4.8 The Council has a duty to act in a manner which is compatible with the Human Rights Act 1998.
- 4.9 A Licence is regarded as property for the purposes of the Human Rights Act 1998. Article 1 of the First Protocol states that:

"Every natural or legal person is entitled to the peaceful enjoyment of his possessions. No one shall be deprived of his possessions except in the public interest and subject to the conditions provided for by law and by the general principles of international law.

The preceding provisions shall not, however, in any way impair the right of a state to enforce such laws as it deems necessary to control the use of property in accordance with the general interest or to secure the payment of taxes or other contributions or penalties."

- 4.10 The Committee must also take into account the effect on local residents. Article 8 states:
 - Everyone has the right to respect for his private and family life, his home and his correspondence.
 - There shall be no interference by a public authority with the exercise of this
 right except such as is in accordance with the law and is necessary in a
 democratic society in the interest of national security, public safety or the
 economic well-being of the country, for the prevention of disorder or crime, for
 the protection of health or morals, or for the protection of the rights and the
 freedoms of others.
- 4.11 Three stage test to be applied:
 - Is the interference in accordance with the law?
 - Is the interference necessary in a democratic society in pursuit of one of the legitimate aims set out above?

Is the decision proportionate ie. Striking a fair balance between the demands of the general interests of the community and the requirement to protect the individual's fundamental rights?

- 2.1 Any party to the decision or anyone who has made a relevant representation [including a responsible authority or interested party] in relation to the application may appeal to the Magistrates Court within 21 days of notification of the decision. On appeal, the Magistrates Court may:
 - Dismiss the appeal; or
 - Substitute the decision for another decision which could have been made by the Council; or
 - Remit the case to the Council to dispose of it in accordance with the direction of the Court; and
 - Make an order for costs as it sees fit.

Any decision by the sub-committee must be based on the facts of the matter presented to it, must accord with statutory obligations and/or guidance and relevant corporate policy, and must be in line with due process, including the duty to give reasons for the decision made.
