**Application for an expedited/summary review of a premises  
licence at: Premier Rowditch 211-213 Uttoxeter New Road  
Derby DE22 3LJ**

**Purpose**

- 1.1 An application for an expedited/summary review of the Premises Licence at Premier Rowditch, 211-213 Uttoxeter New Road, Derby DE22 3LJ from Derbyshire Constabulary by Derby City Council's Licensing Team on 12 December 2019 at 15:09hrs.
- 1.2 This type of application allows the police to fast track a review of the premises licence where they consider the premises are associated with serious crime or disorder or both.
- 1.3 This allows the Licensing Authority to respond quickly where appropriate by taking interim steps.
- 1.4 The application must be on a prescribed form and be accompanied by a certificate issued by a senior police officer
- 1.5 The General Licensing Sub Committee can decide to:
  - modify the conditions of the licence;
  - exclude a licensable activity from the scope of the licence;
  - remove the Designated Premises Supervisor;
  - suspend the licence
- 1.6 Following an expedited/summary review a full review of the Premises Licence must take place within 28 days

**Recommendations**

- 2.1 To consider the information in the report and determine if interim steps need to be taken pending a full review of the Premises Licence at: Premier Rowditch, 211-213 Uttoxeter New Derby DE22 3LJ.
